CAPITAL RAISED BY PRIVATE SHARE PLACEMENT

Ausmon Resources Limited has raised \$245,000 by private placement of 35,000,000 fully paid ordinary shares at \$0.007 per share which is at a discount of approximately 12.5% to the volume weighted average price over the last 5 trading days when the shares traded on the Australian Securities Exchange.
