2 Section B: Reasons for reduced Consultation

Exploration Licence (EL) 8745 is located 30 km's south east of Broken Hill on the south eastern side of Menindee Rd, Exploration is managed by Ausmon Resources.

During the reporting the Company carried out a 3D IP survey at the Eaglehawk Prospect located within Redan Station in the southwest of the tenement.

A plan comprising the location of the survey was sent to Brett Eglinton of Redan Station who approved the timing of the survey and assisted the survey with loads of water.

Field based exploration will be reported on in the next Consultation Report relating to drill testing of the Eaglehawk IP anomaly. The survey was approved by Brett Eglinton who in addition to supplying loads of water for the drilling carried out repairs to some of the tracks.

3 Section C: Details of any Consultation Undertaken

An access agreement has been signed with Redan Station on which most of the licence is located. A meeting has been held was held with the station owner Brett Eglington in Broken Hill and access was agreed to. Pine Point Station is now owned by Redan Station (figure 2). A meeting was also held between the Companies local field contractor AUSSAM and Brett Eglinton prior to the IP survey and RC/Core drilling

3.1 Authority Location




Figure 1: EL8745 showing location relative to Broken Hill




Figure 2: EL8745 showing all pastoral properties

Exploration Licence (EL) 8745 is located 40 km's south east of Broken Hill on the south eastern side of Menindee Rd. in western NSW (Figure 1). Exploration is managed by Ausmon Resources. It consists of 45 units and is situated primarily on Redan Station (Figure 2).
