2 Section B: Authority Location and Work Carried Out

Exploration Licence (EL) 92524 is located 22 km's north-east of Tumut straddling the Wee Jasper Road. Exploration is managed by Ausmon Resources.




Figure 1: EL8954 Location northeast of Tumut

Exploration Licence (EL) 9252 is located 22 km's north-east of Tumut and straddling the sealed Wee Jasper Road Rd, and 46 km's east of Cobar along the Barrier highway in central western NSW (**Figure 1**).

An exploration program was carried out comprising grid-based soil sampling of high priority exploration targets and all samples were scanned with the Companies Olympus Vanta pXRF. Selective soil samples were then sent to ALS in Orange for multielement geochemical analyses. All landowners received the appropriate tenement documents and prior to the field visit a letter was sent outlining the proposed work to be carried out with a time set aside to discuss the exploration in person. All landowners were supportive of the low impact proposed exploration.

The was no field based exploration in the current reporting period

There is no outstanding rehabilitation work to be completed, as no surface disturbing activities were undertaken during the first reporting period to the 6th August 2024.
